

## 1. Call Meeting to Order.

Meeting was called to order at 9:00 a.m. by Chair Lee Krimm.

#### 2. Approval of minutes for 5 May 2018 meeting.

**MOTION** by Connie Baldin, **SECONDED** by Bill Lewis II to approve the minutes of 5 May 2018. **MOTION** carried unanimously.

#### 3. Discussion

a. Committee applications

**Discussion**: Chair Lee Krimm reminded the committee members to renew their applications for the Governing Documents committee.

#### **b.** Pool procedure

**Discussion**: The governing documents committee discussed whether a procedure was needed for access to the pool.

**ACTION**: Grace Wollemann to see if a business policy should be developed regarding the pool.

### c. 2018 ballot bylaws

**Discussion**: Governing Documents questioned the time to resubmit the bylaws submitted to, and approved by, the board but withdrawn from the 2018 ballot.

#### 4. Documents to be reviewed

a. EC Code 7.21(H) Campaign signs and EC Code 7.20 Pets

**Discussion**: Governing docs committee discussed the EC committee and the fact that they disapprove of the changes the governing documents committee made to the campaign policy. The EC committee questioned the enforcement issues regarding animal control but made no objection to the proposed change. The governing documents committee agreed by consensus to revise these two



documents to align with previous changes made to Association rules. When submitting these two changes to the board, the chair is to point out to the board the EC committee's objections to the change being made to EC code 7.21

### b. Business policy S-3 Security cameras

**Discussion**: The governing documents committee agreed by consensus to the S-3 security camera policy.

#### c. Association rule 3.22 Marijuana

**Discussion**: The governing documents committee agreed by consensus to resubmit the original marijuana rule as written below with an explanation to why the re-submission:

**3.22** The use of marijuana in any form is prohibited on Association property.

### d. Proposed new policy A-16

**Discussion**: The governing documents committee agreed by consensus to scratch proposed policy A-16 since it is already covered in the Association rules and employee handbook.

### e. Bylaw 12.02 Enforcement generally

**Discussion**: Patrice Stimpson stated the enforcement policy is enforceable as stated. No change will be made.

### f. Bylaw 3.03 and policy/procedure G-1

**Discussion**: Discussion ensued regarding the insurance requirement relating to a revised policy G-1. Discussion of these two documents was deferred to the July meeting because of the length of policy/procedure G-1. These two documents will be mailed to committee members for their review prior to the July meeting. At the July meeting only proposed changes will be discussed. The rest of the document will not be reviewed.

#### g. Common rules of all committees

**Discussion**: The committee discussed the meaning of task force and initiated review of the document. The committee will discuss the balance of the document at the July meeting.
