Our World of Nature

Plants Can Have Relationships, Too!

Those of us who enjoy nature tend to think of different plants and animals as discreet entities. As we walk the trails, we note the cottontail bunny, the bluebird, various flowers, different species of trees. However, there is much going on that brings these different organisms into meaningful contact with each other. One

aspect of the complexity of plants and animals is their ability to form partnerships with other organisms. I am going to describe four of these relationships that occur locally in our mountains.

Phainopepla/mistletoe: An interesting bird that is found locally, but can be difficult to glimpse, is the phainopepla. It looks like a black cardinal with white wing patches (Fig. 1), (Fig. 2). The phainopepla prefers mistletoe berries for food. In our area, it frequents mistletoe on oak trees (Fig. 3). How does it help mistletoe? When it defecates, it often deposits its "poop" on branches of the oak tree. The gut of the phainopepla has softened

the skin of the mistletoe berry, the "poop" acts as fertilizer and the baby mistletoe finds another foothold into the oak tree. This relationship is not doing the oak tree any good, but it is a satisfactory partnership for the bird and the mistletoe.

Acorn woodpecker/oak tree: Now we come to a relationship that benefits the oak tree. Acorn woodpeckers are the noisy, gregarious woodpeckers that sometimes cause dam-

LEARN THE SOUNDS OF FIRE SAFETY

PMCPOA Emergency Preparedness Committee

October is Fire Prevention Safety Month. This year's theme "Learn the Sounds of Fire Safety" works to educate everyone about the different sounds the smoke and carbon monoxide alarms make. Knowing what to do when an alarm sounds will keep you and your family safe.

What is your alarm telling you?

SMOKE ALARMS:

- A continued set of three loud beeps -- beep, beep, beep -- means smoke or fire. Get out, call 911 from outside and stay out.
- A single "chirp" every 30 or 60 seconds mean the battery is low and must be changed.
- All smoke alarms must be replaced after 10 years.
- Chirping that continues after the battery has been replaced means the alarm is at the end of its life and the unit must be replaced.
- Smoke alarms need to be in every bedroom, outside of the sleeping areas and on each level, including the basement.

CARBON MONOXIDE (CO) ALARMS

- A continuous set of four loud beeps -- beep, beep, beep, beep -- means carbon monoxide is present in your home. Go outside and call 911 and stay out.
- A single chirp every 30 or 60 seconds means the battery is low and must be replaced.
- CO alarms also have "end of life" sounds that vary by manufacturer. This means it's time to get a new CO alarm.
- Chirping that continues after the battery has been replaced means that the unit needs to be replaced.

Make sure your smoke and CO alarms meet the needs of everyone in your home, including those with sensory or physical disabilities. Install a bedside alert light that responds to the sound of smoke and CO alarms. Sleep with your mobility device close to your bed and keep pathways lit with night lights and free from clutter.

Hear a Beep, Get on Your Feet!

Get out and stay out! Call 911.

Hear a Chirp, Make a Change!

A chirping alarm needs attention.



A Message from the Chairman

We've had requests to provide Zoom access to the open board meetings. As many of you recall, our Zoom experiences in general were not that good with technical difficulties by the board and members at home that included bandwidth problems, disconnects, feedback issues and sound problems, and many members complained and requested an end to Zoom.



A few members recently shared that the board's motive in not allowing Zoom was to hide something important – but how absurd when considering an attempt to do so in an open meeting with members present. If the clubhouse router disconnects a meeting, it's not a conspiracy. And, I might mention the attendance and participation at meetings via Zoom was less than these recent open in-person meetings. The meetings can still be viewed on video via our website (<https://pinemountainclub.net/group/pages/board-minutes>). However, we'll take the requests into consideration and re-examine the prob-

lems with sound and the quality of the overall presentation.

The board received a lot of emails, correspondence, and a few phone calls to the general manager with input pro and con regarding the recent resolutions for rule changes, and we appreciate the member input – whether we agree or not. I say thank you to those members for taking the time to be better informed and be involved with your association in a positive manner and attempt to assist us in making decisions that affect you – whether you agree or not.

Unfortunately, there has been – once again – an overabundance of false and misleading information being shared on social media and in the local newspaper related to rules, fines, laws, and due process. It's sad when bad information and lies are being openly shared and quite a few members believe what they read without fact-checking or simply investigating a little more thoroughly. I don't know if we'll ever be able to resolve this situation, but keeping a positive attitude is essential

and being optimistic is the only way we can succeed and be productive in our efforts.

The board passed a motion at the last meeting that will hopefully allow us to continue on the path to improve the clubhouse complex by approving the conceptual design with updates after its review by members at the workshop and final input from the Planning Committee, the Environmental Control Committee, and the directors. Once these plans are fine-tuned and updated, they will be sent off to get a cost breakdown for the project and the next steps to follow will assist us in determining if and how we can afford to continue.

Lastly, I would like to address a recent insinuation that this board only wants to improve the clubhouse complex for outside visitors and STR guests – and that is absolutely false. This project is first and foremost about the members of this association and the future of this association.

--- General Manager's Update ---

It has been a very busy summer and it is almost over. The Concerts on the Greens were well attended. Of course, the pool was probably the highlight for most members this summer. The pool had a lot of activity all summer long up until school started.

The pool was close to capacity on Labor Day Weekend. Members sent in great suggestions for next year's pool season, and I will be looking at implementing some of the suggestions. The pool is open through October 15th and will officially close for the season on October 16th. Those who did not pay their assessment on time (by 5 pm on September 15th) are considered delinquent and will have their pool cards deactivated. Once you become current on your assessment, please bring your pool card to the office and it will be re-activated.

Halloween for kids will be held in Lampkin Park on October 30th from noon to 3 p.m. There will be games, pumpkin decorating, candy, and crafts. And of course, there will be Halloween music. Kids are encouraged to wear their Halloween costumes.

Thursday, Oct. 14 is the last late night the Transfer Site is open for this season. It will revert back to normal hours on Thursdays (8:30am-5pm) after that day.

As we head into fall and cooler morn-

ings and nights, we will be cutting our water down even more. Currently, we are hand-watering the greens and tees only to keep the roots wet so the grass may come back in the Spring. We are now down to using 5,000 gallons of water a day and have been since Aug. 27th when we stopped taking water from the pond. Prior to August 27th we were using 25,000 gallons of water per day and still not watering the fairways, again only watering the tees and

greens. We have been very conservative with the watering as we all understand we are in a drought. Our golf course is part of our CC&R's. Should we lose the greens, it costs approximately \$100,000 to replace each one. That would be around \$900,000 to replace all the greens. It is imperative that we water the greens and tees, and staff is doing a great job of doing just that.

I hope everyone has a good rest of the month and enjoy the cooler weather.

age to houses here in our mountains (Fig. 4). They don't mean to be harmful. They simply are storing acorns for later use (Fig. 5). They are absolutely dependent on several species of oak. They return the favor by accidentally dropping acorns well away from the oak tree. Acorns are heavy and will drop straight

down. The woodpecker gives them a longer ride, hopefully where they can germinate.

Jays/pinyon pine: For another example of bird and tree helping one another,

we come to loud, obvious jays and a very common pine tree. The single-leaf pinyon pine is the prominent pine tree thriving on our drier slopes, frequently on the south sides of our mountains. Both California scrub-jay (Fig. 6) and Steller's jay (Fig. 7) are attracted to the large nutritious nuts of this pine. Having a different style of food storage than the acorn woodpecker, these jays bury their nuts in many different places in soft humus soil. This is ideal for the reproductive success of the pinyon pine, because, as smart as jays are, they will forget where they stored some of their nuts.

Paintbrush/sagebrush/penstemon: (Fig. 8) shows paintbrush, an attractive flower in our open woods. (Fig. 9) includes three plants, the paintbrush, the blue Grinnell's penstemon and the gray foliage of sagebrush. Paintbrush is a partially dependent parasite on the root

systems of several bush species, in this case, probably the sagebrush. It generally does not hurt the host very much. (Fig. 10) displays the penstemon again, this time in association with a pollinating na-

tive bumble bee. Here, the flower feeds the bumble bee nectar (sugar) and pollen (protein), while the bee carries fertilizing pollen from one flower to another. So, we have two relationships between these three plants and one insect. Maybe more

complex relationships are hidden in there, somewhere.

These are just a few examples of the complexity of the natural world around us. Do go outside and enjoy these wonders.

tend these meetings, whether they are able to make it in person, or they choose to attend via Zoom. There should not be any discrimination or blocking of information, we all need access to attend these meetings.

As a nurse that makes both home visits and works in the hospital setting, I understand acutely that many members of a community are not in the best of health; they might have mobility issues, for example, that prevent them from coming to a meeting in person. Another example is that we are in the height of a pandemic, and the expectation that members must take on exposure and risk to their health and possibly contract COVID-19 is unreasonable -- just so they can get the valuable information needed from the meetings and be active community members in the processes that affect their quality of living in PMC.

Pandemic or not, where we live primarily in Santa Barbara, we are progressive and geared toward equal access to the governance process. All city and county meetings are held under both live stream and recorded for later viewing as a standard. Because everyone's voices count.

We are new to PMC, and are interested in hearing the issues, and being a part of the community. Please add Zoom to all meetings as a standard of practice.

Response: We have had a few requests to continue the board meetings by Zoom. This is under consideration by the board.

COMPLAINT

• I had a rude encounter with a Transfer Site employee on August 21, 2021 at approximately 4:30. I pulled into the Transfer Site to unload a couple boxes from some items I'd brought up the hill. They were on the larger side but were not excessively heavy or unwieldy. One was for a headboard measuring approximately 4' high x 5' wide x 2" deep and one was for the footboard measuring approximately 2'6" high x 5' wide x 2" deep.

In the past, I have dropped boxes of similar size at the Transfer Site with no issue. As I pulled the boxes over to the cardboard area, I noticed it was almost empty and as I usually do when it's the case, I jovially apologized to the Transfer Site worker for adding to their work when they are almost finished.

I put the first box in the cardboard area and grabbed the second box only to be angrily confronted by the Transfer Site employee that the large bin was full and that the box wouldn't fit in the bailer, and exactly what was he supposed to do with the

box? I offered to help him break it down, only to have him angrily drag the box back to the cardboard area. I probably should have just left it there, but I asked him if he was really yelling at me for bringing a box to the Transfer Site. I told him I did not believe his response was acceptable behavior and asked what his name was. He refused to tell me, only offering a half-hearted apology the second time I asked for his name.

I threw away the rest of my items, then left. I understand that our employees, particularly the Transfer Site ones, have to deal with a lot of terrible abuse and I have always tried to be courteous to them for the services that they provide us. However, in this instance, I found the employee's response to a completely innocuous situation to be completely unacceptable.

Response: We are extremely sorry about the experience you had at the Transfer Site. It has been discussed and should not happen again. Again, our apologies.
