### Clubhouse Task Force Forms; Open Meeting in December

Coming soon, in December, there will be a Clubhouse Task Force Workshop open to all member.

As you may have read in last month's Condor, there is now a group of Pine Mt. Club members working on a program designed to come up with new ideas on how to bring our aging clubhouse up to date without breaking the bank. This group was appointed by the Board of Directors to approach this subject without any interference.

This group includes several architects, design professionals, financial people, building specialists and involved property owners.

## Just What is the Environmental Control Committee, Anyway?

#### Environmental Control Committee

The Environmental Control Committee, which consists of five volunteer property owners, a recording Secretary, a Board of Directors liaison and the Environmental Control Officer, has the primary responsibility to enforce the PMC EC Code.

The EC staff will assist you in making good decisions to help protect PMC's environment. All projects, big or small, must be approved by the EC Committee and the Board of Directors.

Here are other rules that should be remembered: 1) Pets must be kept on leashes and under control of the owner at all times. They are not allowed in Lampkin Park or near the PMC lakes. Only service animals are allowed on any association property. Owners must pick up after their animals.

2) Loud parties and excessive noise are not permitted. This includes incessant dog barking.

3) Remember, there is a "DARK SKIES" ruling; keep outside lighting to a minimum.

4) Keep up with your yard maintenance, landscaping and clean-up.

5) Please be courteous of your neighbor's peace and quiet.

The group will be exploring aspects of what the problems are, available solutions, and how to keep the costs as low as possible.

We invite all interested parties to come to the workshop to listen and understand what is going to being proposed, how it affects them, and to ask/answer questions via 3 x 5 cards.

This will be a preliminary meeting to demonstrate the direction in which we are proceeding and will be purely oriented towards our initial ideas. There is no time limit for this program. We are just getting started, and it is too soon for us to have financial information available.

The date of the meeting will be published in the next issue of The Condor, in the calendars, on the website and in email blasts.

### A Dialog About Abuse of PMCPOA Employees

I would like to speak about a growing problem we have in our association: employee abuse by members. This is not just harassment, it is a verbal, and sometimes physical, assault. There are numerous state and federal laws that cover abuse in employment situations, and they grow stronger every year. It is our job, as the employer of our people, to protect them as required by these laws.

Right now, this country is seriously divided by a vitriolic, uncivilized atmosphere that seems to be creeping into PMC. Politics aside, it is our statutory responsibility to protect our employees; and uncivilized attitudes toward our employees will not be tolerated here. We will not allow people to throw menus at a waitress, shout racial slurs at our staff, or write despicable communications to any of our employees.

Let me give you an example of some communications received by one of our staff from members: a not-so-veiled death threat; threats against staff and their families; threats of jail time for completely false allegations; and other threats of bodily harm. This is intolerable, and will not be accepted by this association. It is our job, as the Board of Directors, to make sure that the assets of the associa-

## Every Second Counts: Plan Two Ways Out!

**Emergency Preparedness Committee** 

FIRE PREVENTION WEEK IS OCTOBER 8-14. In a fire, seconds count. Seconds can mean the difference between residents of our community escaping safely from a fire or having their lives end in tragedy. That's why this year's Fire Prevention Week theme is "Every Second Counts. Plan 2 Ways Out!" It reinforces why everyone needs to have an escape plan.

• Draw a map of your home with and for all the members of your household, marking two exits from each room and a path to the outside from each exit.

• If you have a second or third floor with no exits, invest in escape ladders so you can safely reach the ground floor.

• Practice your home fire drill twice a year. Conduct one at night and one during the day with everyone in your home, and practice different ways out.

• Make sure all doors and windows leading outside open easily and have nothing blocking your exit.

• Practice staying low to the floor and checking for hot doors using the back of your hand.

• Teach children how to escape on their own in case you can't help them.

• Make sure you have working smoke alarms. They should be installed in every bedroom, outside each sleeping area, and on every level of the home.

• Test smoke alarms at least one a month, and replace all smoke alarms when they are 10 years old.

• Make sure the number of your home is clearly marked and easy for the fire department to see day and night.

• Close doors behind you as you leave; this may slow the spread of smoke, heat and fire.

• Once you get outside, stay outside. NEVER go back inside a burning building.

### • CALL 911!

Reminder: October 19th at 10:19 a.m. is the Great California Shakeout Drill. Practice your "Drop, Cover and Hold." This is also a good time to review your emergency preparedness plan and update your emergency kits.

**'ABUSE'** Continued from page 1 tion are protected from any and all threats. These assets include our employees.

Last year, we posted our revised harassment rules that highlight the fine structure for members committing employee abuse. These rules will be strictly enforced. Employees will be counseled to immediately report such abuse to their supervisor and security, and the member will be removed if appropriate.

I am asking for the Governing Documents Committee to establish guidelines for the removal of members from association property whenever an assault on an employee occurs, and for the member to be excluded from all association amenities until the matter is resolved. That resolution will include a thorough investigation, a hearing, and, if the outcome warrants it, the BOD then making a decision about the length of time said member will be officially excluded.

I will be providing the Governing Documents Committee with the language of the new statutes that provide guidance for protecting our employees. Let it be thoroughly understood that these rules apply to EVERYONE in the association's em-

ployment, from a lifeguard to the General Manager.

This problem must stop. Not only are our employees endangered, but the association, as a whole, is vulnerable to losses from these encounters.

Be respectful people. It's very hard to acquire personnel from such a limited employee pool, and is impossibly hard to keep them when they're subjected to assault from our own members.

### Pre-evacuation Preparation Steps

When an evacuation due to forest fire is anticipated, here is a checklist to follow (if time allows) to give your home the best chance of surviving a wildfire. Home Evacuation Checklist – How to Prepare for Evacuation:

### Inside the House

• Shut all windows and doors, leaving them unlocked.

• Remove flammable window shades, curtains and close metal shutters.

• Remove lightweight curtains.

• Move flammable furniture to the center of the room, away from windows and doors.

• Shut off gas at the meter; turn off pilot lights.

• Leave your lights on so firefighters can see your house under smoky conditions.

• Shut off the air conditioning.

### Outside

• Gather up flammable items from the exterior of the house and bring them inside (patio furniture, children's toys, door mats, trash cans, etc.).

• Turn off propane tanks.

• Move propane BBQ appliances away from structures.

• Connect garden hoses to outside water valves or spigots for use by firefighters. Fill water buckets and place them around the house.

• Don't leave sprinklers on or water running, they can affect critical water pres-

sure.

• Leave exterior lights on so your home is visible to firefighters in the smoke or darkness of night.

• Put your Emergency Supply Kit in your vehicle.

• Back your car into the driveway with vehicle loaded and all doors and windows closed. Carry your car keys with you.

• Have a ladder available and place it at the corner of the house for firefighters to quickly access your roof.

• Seal attic and ground vents with precut plywood or commercial seals.

• Patrol your property and monitor the fire situation. Don't wait for an evacuation order if you feel threatened.

• Check on neighbors and make sure they are preparing to leave.

Did you know that PMCPOA has an email blast system that is used to provide information in the quickest way possible?




