

Pine Mountain Club Dog Park Club Membership

The PMC Dog Park is an amenity that is available to all PMC residents to whom Association membership privileges have been conveyed, i.e. their guests.

Membership is subject to the following conditions being met:

DOG PARK RULES

- Dog owners are responsible for the behavior of their dogs at all times.
- All members use the park at their own risk.
- Children under age 12 are not permitted in the park without a parent or guardian over the age of 18. It is strongly urged that young children not be brought to the dog park for their own safety.
- Owners must remain with their dogs at all times. Dogs may not be left unattended and must be in view of, and within voice control of the owner at all times.
- Pinch, chains and spiked collars are not allowed because of their potential for harm.
- Dog's owner/handler is responsible for picking up and disposing of all their dogs waste into the 5. containers provided.
- Dogs showing any signs of aggression must be leashed and immediately removed from the park. 7.

MEMBERSHIP APPLICATION

- 1. All dogs using the park must have a current license or rabies vaccination certificate. A copy must be submitted with your application for each dog that will use the park.
- Dogs using the park must wear a current County dog license (any county) or an ID tag bearing the dog's name and the current phone number of the owner.
- 3. All users must sign a Release of Liability document. A copy is attached.

I hereby acknowledge that I have voluntarily applied for permission to use, with my dogs, a dog park area in Pine Mountain Club Property Owners Association (PMCPOA). All information provided in my Membership application is accurate and truthful to the best of my knowledge. I understand that falsification of information may result in revocation of dog park privileges.

I warrant that my dog(s) that use the dog park area have been vaccinated as required by applicable law and will provide evidence of same to PMCPOA.

I further understand that the dog park is located on property of PMCPOA, but that PMCPOA does not operate the dog park and PMCPOA assumes no liability in connection with the use of the dog

The dog park is operated by PMC Dog Park and I understand that PMC Dog Park may impose other requirements for the use of the dog park in addition to what is stated herein.

I understand that unleashing my dog and being physically present at a dog park area involves risks of injury to me, any individual accompanying me, other people, my dog(s) and other dogs. Risks include, but are not limited to, exposure to aggressive dogs, their unpredictable behavior, and lack of training, as well as dog fights, dog bites, theft or unlawful capture, escape over and under fences. ___(initial)

I further understand and assume that despite the efforts of Pine Mountain Club Property Owners Association and the Dog Park Committee to ensure that owners have compiled, there is risk that not all dogs present in the dog park may be vaccinated for rables, as required, and that this could result in harm to other dogs and human beings. _____ (initial)

I also understand that use of dog park areas is self-directed and not directly supervised by any agent or employee of the Pine Mountain Club Property Owners Association. I assume all risks of personal injury and/or property damage associated with using the dog park, including fixtures and equipment, in a responsible, unsupervised, and self-directed manner. _____ (initial)
