## **PMCPOA Board of Directors Election Filing Deadline 4/9**

It's PMCPOA election season again. A reminder that the filing deadline for potential PMCPOA Board of Director candidates is Thursday, April 9 at 5 p.m. Letters of Intent, the Candidate Filing Form, the biography/resume and the signed Acknowledgment of Election Materials form are all due at that time.

Once the Board of Directors approves the election packet during its April meeting, the Corporate Secretary will direct that the approved packet be submitted for printing.

The next step in the PMC election process is the "Meet the Candidates" members' open forums, which had been scheduled for Saturday, April 25 from 1-4 p.m. and Friday, May 8 from 6-9 p.m. The April forum has been postponed/ cancelled, and the May forum is subject to postponement or a change in format, from a live meeting to a virtual gathering, depending upon the COVID-19 conditions. We will keep you posted about the situation and both forums.

The forums are hosted by the Election Committee and moderated by the Corporate Secretary.

These forums are question-and-answer sessions in which candidates may state their opinion or position. The forums are typically conducted as follows:

1. Member questions will be submitted on 3x5 cards, which will be sorted into four (4) categories: general, candidate specific, inappropriate and repetitive. Inappropriate questions will be discarded. Repetitive questions will be narrowed down to one (1) or two (2) questions that cover the most issues asked by all.

General questions will be presented to the candidates through a lottery system. All general questions will be placed in a raffle drum and then be drawn at random. They will be given to the moderator to present to the candidates.

Candidate-specific questions will be set aside and asked as time permits.

2. Members will be limited to a maximum of five (5)

## SPRING CLEAN YOUR MEDICINE CABINET:

• Check expiration dates on the prescription and over-the-counter medicines. Do not throw medicines in the trash or flush them down the toilet. Put them a bag and, when the COVID-19 restrictions are lifted, take them to a "Medicine Take Back" location. The Kern County Sheriff's Office in Frazier Park has a drop-off box. Also, some medical facilities have drop-off boxes.

• Check your make-up and personal-care products. The shelf life of most products after opening is eight months or less.

## SPRING CLEAN YOUR GARAGE/CLEANING PRODUCTS:

• Get rid of old and unwanted bug killers, automotive supplies, lawn and garden pesticides, cleaners, degreasers and fluorescent and CFL light bulbs. Fluorescent and CFL light bulbs should never go in the trash. Most hardware stores have a drop-off box. Hazardous products that say "CAUTION," "WARNING," "DAN-GER" OR "POISON" on the label cannot go in the trash. Take them to a Hazardous Waste Collection Site:

#### The Lebec Transfer Station (300 Landfill Road) is holding a Household Hazardous Waste day on May 23rd from 9 a.m. to 12 p.m.

\*\*\* Please note that this event is subject to cancellation or rescheduling depending upon the COVID-19 situation.

### ACCEPTED MATERIALS:

Batteries, motor oil, paints, light bulbs, sharps, pool chemicals, automotive products, cleaning products and more.

### TRANSPORTATION GUIDELINES:

• A maximum of 15 gallons, or 125 pounds of waste/material, may be transported per vehicle, per trip.

• The contents of any single container of waste/materials may not exceed five gallons.

• Do not mix waste/material.

• Waste should be in the original container. If not, label the container as to its contents.

• Container must be closed, sturdy, not leaking and protected from breakage.


Members may request copies of the open Board Meeting minutes. These requests should be made in writing to the Corporate Secretary. There is a charge per page for making copies of the minutes.

# A Message from the Chairman

As I type this message, I realize that many things may have already changed with respect to our response to and impact of the COVID-19 pandemic,



so I will write that I am confident we continue to follow guidelines and mandates to keep our community safe and hope you are doing your part as well to stay safe wherever you may be.

At our last Board meeting, the Board was presented with an updated version of our 2020/2021 budget that does not include any assessment increase. We are still a little uncertain how this year will now fiscally end (and the next will begin) as we face revenue losses from the cafe, lounge, Pro Shop and Transfer Site (for recyclables), but it is a fluid situation that is changing daily while we deal with the impact of the virus and recycling sources. I anticipate that our Condor Cafe will still be open for dinner take out when you read this message, and if so, I encourage you to place an order or two or more to help keep a revenue source open and employees working. I also encourage you to likewise support the restaurants in the village.

Regarding the status of Phases 1 & 2 of the Clubhouse Renovation Project, and concerns about moving forward with these projects during these uncertain times, we have now allocated the money, signed the contracts and we are ready on our part to proceed. However, I do not anticipate the projects physically proceeding during the pandemic crisis and do not expect the contractors to begin construction until afterward. There are no start dates currently for these projects. And, the old pool will not be resurrected due to the costs and the current closures of all pools during the crisis.

lage and Community Theater, along with just having our grand kids come up and play in the snow!"

In addition to his long professional career, Burkett holds licenses in competition auto racing, is a private helicopter pilot, is a certified state instructor in CPR/First Aid, taser and firearms and is a range safety officer. He is indeed a man of many talents: Burkett is one of our very own entertainers here in PMC, performing regularly as a solo artist and with his band, "Journey-in-Time."

Burkett said he decided to run for the PMCPOA Board as a way to get involved in the community. He had served as VP of the homeowners' association board in Ventura for five years prior to moving to Pine Mountain Club, and wanted to get re-involved. "I think it is good for people to get involved and give back where they live," he said. "Be a volunteer at your local church or local school, coach a kids' sports team, join a committee or just serve somewhere if you possibly can."

In the nearly two years that he's been on the PMC Board, he says the greatest challenges he and his fellow Board members face include getting things done in a timely manner since the Board only meets once a month; balancing the obligations as a Board to maintain the association's many assets and facilities while not overspending by placing unnecessary debt or special assessments on the members; and accurately communicating future goals and objectives clearly to the community members.

Among the greatest successes Burkett has seen in his tenure on the Board is the agreement to adopt and approve a phased master plan to address the issues faced in the aging clubhouse facility. "This includes our overdue need for facility improvements and repairs, the over-crowded employee and meeting space requirements, poor employee working conditions and ADA compliance, to name just a few." He adds, "One of the real advantages and values of a phased master plan is that we can move forward with each phase independently as we can afford it." He continued, "Another significant Board accomplishment was made recently in adding our facilities assets to the Reserve Study so we can now budget and designate money for future facility improvements."

Burkett says that serving on the Board of Directors for PMCPOA has been a privilege that at times can be loosely compared with being on a jury. "Getting nine very skilled and diverse individuals with different professional backgrounds and opinions to totally agree on any issue is no easy task," he said with a laugh. "However, this is exactly what makes a great Board of Directors, and you can be assured that everyone on your current Board wants what is best for PMC, contrary to what has been presented on social media."

He added, "By design, our bylaws require that a third of the current Board members be re-elected each year, giving excellent opportunity for new ideas and opinions to be introduced to the Board every 12 months. If you want to affect real change here in PMC, consider submitting your name to be on a future ballot, join a committee and become involved!"

# A Small Horse with a Very Big Job

*Mr. Biggs, PMC Equestrian Center* I would like to introduce myself: My name is "Mr. Biggs," and I am an appaloosa miniature horse who's living large at the Pine Mountain Equestrian Center. About five years ago, I met my new mom, Lori Harmon. I first met Lori when she was looking for a special miniature horse to work with children and teens.

When Lori arrived at the ranch where I was born, she was shown many beautiful miniature show horses. I watched Lori from afar as the farm owner was giving her the grand tour. The stablehands were presenting all of the available sale horses. Each horse was impeccably groomed and demonstrating their talents; in halter, conformation and carriage driving.

Lori spent the whole day looking at horses and had chosen a few that she was interested in. As they passed by my pen, I heard her ask the stable owner, "who's this little guy?" The owner replied, "I don't think you would be interested in him; both his sire and dam are winning show horses, but this little colt was born with congenital defects and cannot be shown." I watched as they both proceeded down the breezeway looking at other horses.

It was late in the evening. Lori with pen and paper in hand — was taking notes and walking through the barn. She stopped in front of my stall and spoke to me in a soft voice. I wouldn't look at her. She then quietly opened the gate and entered my pen. I was afraid and darted to the furthest corner trying to hide myself. Lori did not say a word, but sat down in the center of my pen with her back turned towards me.

For the longest time, I didn't move a muscle and neither did she. My curiosity finally got the better of me and I inched my way a litter closer. My nose touched her hair and Lori held perfectly still. I mustered the courage to sniff her back and arms. Still sitting on the ground, Lori reached out and scratched my withers, just like my mother did when I was foal. Unlike the show hors-

es, my coat was unkempt and my mane knotted, but Lori didn't seem to care. In those few moments, I felt special. When Lori stood up, it startled me, and I darted back to the safety of my corner. As she left my pen, I thought I would never see her again.

To my surprise, the following morning I was loaded into a horse trailer and headed to my new home. When I arrived at the Equine Alliance Youth Foundation, I was greeted by some very special full-sized horses. These horses were used for equineassisted therapy for children and teens. At first, I was worried that I wouldn't have an important job like the other horses because of my size and disabilities.

My new mom reassured me that I was special and that she had a very important job for me. Lori spent hours working with me every day. My confidence improved as I learned how to walk up and down stairs, navigate slippery schoolroom floors, walk in parades and even ride in an elevator. This was something even the big horses couldn't do.

I was so excited and could hardly wait to have my very own special children to care for. Finally, that day came... a 4-yearold girl arrived at the ranch who had special abilities just like me. She was born with a congenital birth defect. I was so excited to meet her, but when I approached, she shrieked and clung to her mother's leg. I walked up to her very quietly and nuzzled her hand. She reached out tentatively, touching my nose and squealing out in delight. Lori took us both to the arena and my new friend led me around the arena. We were both so happy and played for hours.

Since that day, I have worked with many people with special abilities, young and old alike, from ages 2 to 86. Like these children with special abilities, there is nothing I cannot do. It's truly our love and determination that makes us special.

# Garlic Chicken Piccata by Chef Mike

#### Michael Beurer, PMCPOA Food and Beverage Manager

Garlic Chicken Piccata is an easy family favorite recipe adding a garlic twist to an authentic Piccata! Chicken lightly dusted with flour and Parmesan cheese, lightly fried until a soft golden crust forms and finished off in a buttery, silky, lemon garlic sauce with capers and white wine or stock is sure to please!

PREP: 10 MINS

COOK: 20 MINS

TOTAL: 30 MINS

SERVES: 6

#### **INGREDIENTS**

3 large boneless and skinless chicken breasts halved horizontally

3 tablespoons flour (all purpose or plain)

3 tablespoons fresh Parmesan cheese, finely grated

1 1/2 teaspoons salt

0.38 teaspoon black cracked pepper

6 tablespoons unsalted butter, divided

3 tablespoons olive oil, divided

6 large cloves garlic, minced

0.38 cup dry white wine (can be omitted)

1.13 cup chicken stock

3 tablespoons fresh lemon juice



0.38 cup brined capers, rinsed 0.38 cup fresh parsley, chopped Parmesan Cheese to serve

### INSTRUCTIONS

In a shallow bowl, combine the flour and Parmesan cheese. Season the chicken with salt and pepper; dredge in the flour mixture; shake off excess and set aside.

In a large pan or skillet, heat 1 tablespoon of butter and 1 tablespoon of oil over medium-high heat. When hot, fry 2 pieces of chicken first until golden on each side and cooked through (about 3-4 minutes each side, depending on the thickness of your chicken). Transfer to a warm plate.

Melt 1 tablespoon of butter and another tablespoon of olive oil. When hot, fry the remaining chicken until browned on both sides. Transfer to plate.

In the same pan, melt one more tablespoon of butter. Fry the garlic for 30 seconds until fragrant. Add the wine and bring to a boil, scraping up any brown bits from the bottom of the pan for extra flavor. Cook until wine almost evaporates, stirring occasionally.

Pour in the stock, lemon juice and capers and allow to boil until reduced slightly (about 6 minutes). Adjust salt and pepper if needed.

Add remaining butter to the pan, allow to melt, then add chicken back into the pan along with all of the juices from the plate and simmer for 5 minutes to heat through.

Garnish with parsley and serve immediately with Parmesan cheese, if desired. NOTES

\*If your sauce doesn't thicken for some reason or you're pressed for time, mix together 1 teaspoon of cornstarch with 1 tablespoon of water until smooth and lump free, then pour it into the center of the pan while sauce is boiling (before adding your chicken back into the pan — at Step 5). Whisk it in quickly to blend it right into the sauce. Once your sauce has thickened, add your chicken and continue recipe.

Reminder: Keep calm and wash your hands.
