### HAVE YOU CHECKED YOUR FIRE **EXTINGUISHER LATELY?**

PMCPOA Emergency Preparedness Committee

When used properly, a portable fire extinguisher can save lives and property by putting out small fires. Portable extinguishers, intended for the home, are not designed to fight large or spreading fires. However, even against small fires, they are useful only under certain conditions:

- The operator must know how to use the extinguisher. There is no time to read directions during an emergency! Remember the "PASS" word: Stand 6 to 8 feet away from the fire and follow the four-step "PASS" procedure. PULL the pin out. AIM low, pointing the hose at the base of the fire. SQUEEZE the lever below the handle. SWEEP from side to side. If the fire does not go out immediately, leave the area at once.
- Make sure the extinguisher is in good working order and fully charged. Check the gauge to make sure the pressure is at the recommended level. Make sure hose and nozzle are in working order. Shake dry-chemical extinguishers once a month to prevent the powder from settling. Immediately replace the extinguisher if it needs recharging or is damaged in any way.
- Select the proper extinguisher. For the home, select a multi-purpose ABC extinguisher (can be used on all types of home fires) that is large enough to put out a small fire, but not too heavy to handle.
- Extinguishers should be installed in plain view above the reach of children, near an escape route and away from stoves and heating appliances.

Before you begin to fight a fire:

- Make sure everyone has left, or is leaving the building.
- Make sure the fire department has been notified by calling 911.
- Make sure the fire is confined to a small area and that it is not spreading beyond the immediate area.
- Make sure you have an unobstructed escape route to which the fire will not spread.

### Remember: If It's Too Cold for YOU, It's Too Cold for THEM

PMC Patrol

Now that winter temperatures are dipping below freezing, PMC Patrol would like to remind residents that it's time to bring your pets indoors, especially at night.

The American Veterinary Association advises that dogs and cats should be kept inside during cold weather. It's a common belief that dogs and cats are more resistant than people to cold weather because of their fur, but this is not true.

Like people, cats and dogs are susceptible to frostbite and hypothermia and should be kept inside. Longer-haired and thick-coated dog breeds, such as huskies and other "snow dogs," are more tolerant of cold weather; but no pet should be left outside for long periods of time in temperatures below 40 degrees Fahrenheit. To do so is considered animal cruelty/neglect.

Cold cars also pose significant risk to your pet's health. Your car can rapidly cool down in cold weather, and becomes like a refrigerator. Pets that are young, old, ill or thin are particularly susceptible to cold environments and should never be left in cold cars. Limit car travel to only that which is necessary, and don't leave your pet unattended in the vehicle.

### A Message from the Board Chair

The January Board meeting was greeted with snow and ice. Not a great deal of it, but enough to remind us that we live in the mountains and that snow is part of the scene. So far this season, it has been mild and very dry, but I hope that will change.

Part of being prepared is dealing with the worst part of a snow event: the seemingly inevitable traffic problems and waiting for the CHP to pass you through the chain checkpoint so you can get home.

This year, the Frazier Park Chamber of commerce initiated a new pass for use by all mountain residents to identify themselves, thus allowing the CHP to wave them through. It is a tag that hangs from the rear view mirror and is available for purchase at various locations. PMC has had a sticker for the windshield for many years. We were concerned that it might not be honored in the same way it has in the past, but after checking with them, CHP has as-

sured us that they will recognize our sticker going forward. Either the pass or the sticker will work; both will help you deal with the traffic problems that are surely going to reoccur sometime this year. Be prepared.

January also marks the beginning of the annual budget process. I have appointed the Budget Working Group required by Bylaw E-14. The group includes the Chairman and Treasurer of the Board, Chairman of the Budget and Finance Committee, The General Manager, the Chief Financial Officer and two additional Board members, this year Garry Kemmer and Richard Ballard. The calendar of meetings for the members is available on the website and posted in the Clubhouse. Budget development is always important, so plan on participating.

There have been a number of questions regarding the dissemination of the actions the Board takes as a result of a hearing.

We do not publish the action taken; only the fact that action has been taken. We believe that our member's privacy and right to confidentiality are paramount in these situations and should guide our actions in the future.

The New Year always brings with it a number of new laws that require changes, and this year is no exception. To name one, the legalization of recreational Marijuana does not affect the right of employers to maintain a drug-free workplace, as is the case with PMC. Further, our current rules regarding smoking at the Clubhouse will remain in effect. I am sure we will receive more alerts as the implications of the new Federal Tax Law become clear and the State of California responds. Stay tuned.

On a final note, if you have not checked out the Clubhouse activities lately, come join us on a Friday or Saturday night. You will be pleasantly surprised.

### -----General Manager's Update -----

Karin Shulman

I would like to start by letting the membership know that the Bistro is subject to further implementation of recommended changes. The Bistro staff and I started making changes to the Friday and Saturday night dinners before the October Board meeting vote to implement the Bistro Task Force recommendations. I would like to share with you in part what I have sent the Bistro Task Force. "Our revenue from June to November decreased by nearly 39% (\$11,000) due to the time of year and the change to a buffet style; however, our expenses have also decreased in that time period by 50% (\$31,124), which I think is a great start in the right direction. Furthermore, our losses have decreased by almost 59% (\$11,000). We are diligently working daily on improvements, cutting expenses, reducing staffing and reducing losses." Be patient as we continue to move forward with the Bistro Task Force recommendations. Be assured the Bistro is top priority as I continue to manage not just the Bistro but the entire association.

### Entertainment Update

Along with changes to the Bistro, we have a new Recreation Supervisor, Jessie Hales, who has revitalized the Condor Lounge on Friday nights with free acoustical guitarists (all local talent) and changing up Saturday night bands. On a recent

evening, we had a comedian in the Condor Room for \$10 per ticket and we sold over 67 tickets. Another night, we had a DJ in the lounge for entertainment and dancing. We have been pretty busy, and I am hearing comments that it is like old times. We have dinner theater coming soon too, as well as a children's theater. Please avail yourselves to some fun and come see what everyone is enjoying. Kudos to Jessie Hales!

### Snow on the Roads

But, what doesn't take time? And where is it more meaningful to give that time than in making the place where you live better?



# Please Slow Down on PMC Roads

A reminder to all PMC residents to please SLOW DOWN and be cautious on our roads. Aggressive driving appears to be on the increase. With icy roads happening off and on, that is a very dangerous practice. Please be extra cautious on the roads that are steep and narrow, and do not exceed speed limits or run stop signs. # **Chain Control Laws Apply in PMC**

With the long-awaited arrival of winter weather, icy roads have returned. Pine Mountain Club is a California Highway Patrol chain control restricted area. Chain control laws apply equally to all vehicles entering this area.

There are three levels of restrictions pertaining to traction devices. At one time or another, all three levels have applied to our area roads. It is important to have the necessary equipment in your vehicle at all times during winter months.

When chain controls are established, signs will be posted along the road indicating the type of requirement. Here are

the three requirements in California:

Requirement 1 (R-1): Chains are required on all vehicles except passenger vehicles and light-duty trucks under 6,000 pounds gross weight and equipped with snow tires on at least two drive wheels. Chains must be carried by vehicles using snow tires. All vehicles towing trailers must have chains on one drive axle. Trailers with brakes must have chains on at least one axle.

Requirement 2 (R-2): Chains are required on all vehicles except four-wheel-drive vehicles under 6,500 pounds gross weight and equipped with snow tires on all four wheels. Chains for one set of drive wheels must be carried by four wheel-

drive vehicles using snow tires.

Requirement 3 (R-3): Chains are required on all vehicles without exception.

R-1 and R-2 are the most common conditions. A highway will often be closed before an R-3 condition is imposed. You must follow the directions on the signs posted for chain controls or any instructions given by Caltrans or CHP personnel at chain control check points, even if these are at variance with broadcast road condition reports.

### Snow-tread Tires:

The California vehicle code section 558 defines a snow-tread tire as follows: "A Snow-tread tire is a tire that has a relatively deep and aggressive tread pattern compared with conventional passenger tread pattern." Snow-tread tires can be identified by examining the sidewall of the tire where the letters MS, M/S, M+S or the words MUD AND SNOW have been stamped into the sidewall.

### Tire Traction Devices:

The California vehicle code section 605 defines tire traction devices as follows: "Tire Traction Devices are devices or mechanisms having a composition and design capable of improving vehicle traction, braking and cornering ability upon snow or ice-covered surfaces. Tire traction devices shall be constructed and assembled to provide sufficient structural integrity and to prevent accidental detachment from vehicles. Tire traction devices shall, at the time of manufacture or final assembly, bear a permanent impression indicating the name, initials or trademark of the assembling company or primary manufacturer, and the country in which the devices were manufactured or assembled in final form."
